	the school as per affiliation bye laws and subject to the availability of room size of greater than 500 sq ft.
2	The ramp / lift to access upper floor is not available. Hence the school is directed to construct ramp or to install lift within 3 months and submit the compliance on SARAS portal.
3	As per RC report, there are CWSN toilets one each for boys and girls, which is not sufficient. Further, it is reported by RC that, the CWSN toilets are not as per norms and to be made more spacious so as to enter the wheel chair inside and can navigate within the cubicle. Hence the school must ensure separate CWSN toilets for girls and boys (with proper infrastructural facilities) along with normal toilets for students and staff on each floor and submit the compliance on SARAS portal within 3 months. The school is advised to refer circular No.5/2023 for CWSN facilities.
4	The school shall conduct training of its teachers with CoE Vijayawada within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-
